## FEES

- A. The total Breeding Fee for Cosmeo is \$2500.00 CND which includes first collection but does not include shipping.
- i. The Breeding Fee of \$2500CND is due to Keystone Farms upon signing this contract. Keystone Farms will send an invoice via email within 1 business day of receiving this completed contract.
  - ii. \$300CND is due to Keystone Farms per collection, prior to shipment.
  - iii. A non-refundable Booking fee of \$500CND is included in the Stud Fee.
  - iv. Shipping to the USA is \$565CND per shipment
  - v. Shipping within Ontario is \$250CND per shipment
  - vi. Shipping outside of Ontario but within Canada is \$270CND
  - vii. If Mare owner wishes to have shipping fees billed directly to their FedEx account, they must include it above.
  - viii. If mare owner wishes to have a disposable shipping container used, there will be an additional \$100 fee per shipment
  - ix. All fees (breeding fee, shipping and collection) are subject to 13% HST

## PAYMENT

Fees can be paid by credit card, money wire or E-Transfer. Payments made by credit card are subject to a 4% fee per transaction. All contracts must have a credit card on file which will be used for unpaid invoices.

## TERMS

### 2 Year Live Foal Guarantee

- A. 2 year “Live Foal Guarantee”; a live foal by definition, will stand and nurse within 48 hours after birth. This contract is only valid for the year that this contract is dated and the following year and will not be extended into a third year. The LFG does not extend to accidents which result in the death of the foal, such as aggression from the mare or paddock accidents.
- B. A maximum of 3 semen shipments will be provided per year to fulfill this contract.
- C. After the first collection, additional semen will only be provided if the Mare Owner has provided a completed Breeding passport confirming the mare is not in foal. This must be signed by the Mare Owners veterinarian.
- D. The “Breeding Season” is defined as commencing **April 1 and concluding on the 1st of October** of each calendar year.
- E. The breeding fee covers only one (1) live foal.
- F. The semen provided under this Agreement shall only be used to inseminate the Mare identified herein, and for no other purpose whatsoever. Mare Owner shall not use, retain, or sell any unused Stallion semen for any purpose whatsoever without written and signed consent by Stallion Manager.
- G. Contract can be transferred to another mare of the same Mare Owner with written consent from Stallion Manager. The contract period is not extended.
- H. Contract is transferable to new owner or Buyer of mare, should contract mare be sold in foal. The contract period is not extended.
- I. Embryo Transfer and ICSI is allowed; however under these specific conditions:
  - i. Mare Owner must notify Stallion Owner if Mare is to be bred for Embryo Transfer/ICSI.
  - ii. Contract only allows for one live foal. If additional foals or vitrified embryos are produced, 50% of the stud fee is due within 14 days of birth or vitrification.
  - iii. No LFG is offered on embryos that are vitrified before transferring to recipient or vitrified embryos intended to be implanted in the future.
- N. A clean uterine culture and cytology is required on the mare by a licensed veterinarian if a mare fails to conceive after 2 cycles before a third collection will be shipped. Proof must be provided to the Stallion Manager.**
- O. If by the end of the breeding season for the first year of this contract the Mare has not settled, or has failed to maintain a pregnancy, Mare Owner agrees to provide written confirmation that the mare is barren, that the mare has a clean uterine culture & cytology, & that the mare has been properly cared for signed by a Veterinarian within 30 days of the end of the aforementioned Breeding Season. The Agreement may then be carried forward to the following year. This contract may not be extended for a third year.
- P. If the Mare gives birth but fails to produce a “live foal” as previously defined, Mare Owner must notify Stallion Manager within 48 hours of the foal’s death and provide written certification from a Veterinarian within 5 days. This certification must include verification of the death of the foal, an explanation for the foal’s death, and confirmation that the mare has been properly cared for & monitored during all stages of her pregnancy & foaling. Once this confirmation has been received, the Mare may be rebred to the Stallion, or Mare Owner may substitute a different mare after approval from Stallion Manager.
- Q. If the stallion dies or is no longer available during the contract period, one dose of frozen from the same stallion will be made available for each mare if available. Alternatively, the mare owner will be refunded the stud fee.

- R. Keystone Farms assumes absolutely no responsibility for any loss or damage to the mare. The Mare Owner shall assume all responsibility for the condition of the Mare and shall bear all risk of loss or damage to the Mare whether by death, disease, injury, infection, or otherwise.

## REQUESTS AND SHIPPING

- A. All semen is shipped via an Equitainer using the fastest option available. If the Mare Owner wishes to have semen shipped in a disposable container, these requests must be made at the time that this contract is signed. There is an additional fee of \$100CND per shipment if you request a disposable shipper. **CHECK HERE FOR DISPOSABLE CONTAINER**
- B. All transportation costs for the semen and container shall be the responsibility of the Mare Owner.
- C. Absolutely no semen will be shipped if there is an outstanding balance owed by the Mare Owner or if the required breeding passport has not been completed.
- D. Collection schedule is M-W-F, however the Stallion Manager will do their best to accommodate the Mare Owner with enough notice.
- E. **The Mare Owner must notify the Stallion Manager before 7pm EST the night before they require shipment of the semen. Ex: If mare is to be bred Tuesday, semen must be ordered by 7pm on Sunday.**
- F. **All requests must be sent via email to cosmeostallion@gmail.com or by text to Amanda at 905-429-0494**
- G. If Mare Owner cancels their request for semen after 7am EST on the day of collection, then Mare Owner is still required to pay the collection fee.
- H. Keystone Farms holds no responsibility for shipping errors, routing errors, or mistreatment of shipper by shipping company, which might result in damages to fresh cooled semen.

## MARE OWNER'S DUTIES

Mare Owner acknowledges & agrees to the following conditions:

- A. Stallion Manager's sole responsibility under this Agreement is to provide semen from the Stallion to Mare Owner in good faith so as to allow for the conception of (1) foal. This Agreement does not guarantee that Mare will become pregnant during the contract period nor does it guarantee that Mare will provide Mare Owner with a live foal at the end of this contract period. Stallion Manager agrees to provide fresh semen from the named Stallion and Mare Owner agrees to do all due diligence with their Veterinarian to give Mare the best chance of conceiving and carrying a foal to term.
- B. Mare shall be in healthy and sound breeding condition and free from infection or disease. All necessary veterinary examinations and treatments will be carried out by Mare Owner in order for the mare to conceive, maintain her pregnancy, and deliver a live foal.
- C. Mare Owner will complete the Breeding Passport and notify Stallion Manager of mare's pregnancy status after each insemination or all guarantees are null and void.
- D. Registration of the resulting foal is strongly encouraged during its first year of life and is the sole responsibility of Mare Owner. If Mare Owner chooses to use a registry with whom Stallion is not currently activated or directly approved, Mare Owner is responsible for any "Outside Stallion Fees" that may apply.

## EQUITAINER LIABILITY

If Keystone Farm's equitainer is not returned within 7 working days from Mare Owner's receipt of said equitainer, Mare Owner's credit card account will be charged a \$10.00CND per day late fee. If the equitainer is damaged or not returned to Keystone Farms within a three (3) week period, Client's credit card will be charged \$500.00CND to cover the replacement of the equitainer in addition to the late fees that have been incurred. We recommend insuring the shipper when sending it back to Keystone Farms. Mare Owner must include a credit card number, expiration date, 3 digit code and card holder name in this contract.

# B R E E D I N G P A S S P O R T

This record must be dated and signed by the attending veterinarian on each occasion that the mare is inseminated or checked for pregnancy. This record must be returned to Keystone Farms after each insemination and at the commencement of each breeding season. If this has not been provided, no additional semen will be provided to the Mare Owner and no breeding certificate will be issued. We recommend that all mares are ultrasounded at 14, 30, 60 & 90 days post insemination.

# B R E E D I N G T O C O S M E O

1. Send your mare's information to us at [cosmeostallion@gmail.com](mailto:cosmeostallion@gmail.com) for approval. Include a conformation photo, sire x damsire, age, birth registry & any approvals. Please also include a description of any show record & previous offspring information. Once approved, we will forward you a breeding contract.
2. Complete breeding contract & send payment. Sign & remit your contract via email. We will send you an invoice via email. No semen will be shipped until payment is received in full, non-negotiable.
3. Request collection. Keystone Farms collects on a Monday/Wednesday/Friday schedule, but with notice can we try to make semen available 7 days a week if our schedule allows. Please make your request for collection directly to Amanda by 7pm EST the day BEFORE collection/shipment is needed. Requests must be sent via email or text to Amanda ([cosmeostallion@gmail.com](mailto:cosmeostallion@gmail.com), 905-429-0494). Semen can be picked up at the farm or shipped overnight via Fed-Ex. If you have an existing fed-ex account, you can provide us with your account number to be billed directly for shipping costs. Please remember that semen will arrive the day AFTER it is shipped and same day shipping(counter to counter) is not an option. Requests for semen will be honored in the order received in the event that there are more requests for a particular day than Cosmeo can "service."
4. Please keep holidays in mind when planning your inseminations as Fed-Ex will be closed. Semen requested on holidays may not be able to be shipped, or risks delays. These dates are noted in your contract. Semen needs to be picked up at the farm on these days.
5. Once your mare has been inseminated, you must ship the Equitainer that the semen came in back to Keystone Farms via Fedex within 7 days. Please close the container with the zip tie provided. Please provide the tracking number to us. We recommend insuring the shipper for \$500 CND. Please make sure all coolant cans and semen container are included.
6. Report the results of your breeding. Please complete the "breeding passport" that was attached to your contract and submit it to us at each ultrasound to report her status. Additional semen will not be provided if this breeding passport is not completed and sent to us as required.
7. Report birth of foal. Tell us all about your new Cosmeo foal! Send photos, especially ones we can share on social media!
8. Register your foal. Please register your foal before its first birthday. We cannot stress this enough. If you need assistance or guidance, we're happy to help.
